## Minutes of the NHACC Annual Business Meeting

November 6, 2021

Call to order by President Zach Boyajian at 8:30 am

**President's Remarks** Zach Boyajian began the annual meeting by welcoming member conservation commissions and recognizing our annual meeting sponsor, Amy Manzelli of BCM. He discussed the importance our natural world provides for human health and the role it has played during this pandemic. He recognized departing board member Cris Blackstone and provided an introduction of our current board of director's members and staff. Executive Director Barbara Richter talked of the pleasure we get from natural spaces and how they serve as her anchor of joy. She recognized the role conservation commissions play in protecting our natural spaces and highlighted our 50<sup>th</sup> anniversary.
