Living with Wildlife; Don't Attract Bears

As the temperatures warm, black bears are coming out of hibernation. They typically emerge from dens during late March or early April looking for food. Everyone should take down their bird feeders and clean up all bird seed by April 1 to prevent attracting bears to your home. According to NH Fish & Game, the black bear is the only bear species in New Hampshire. Dens may be burrows, caves, hollow trees, windthrown trees, slash piles or leaf nests on the ground. Population estimates range between 4,800 to 5,000 bears statewide. Check out the NH Fish & Game website for more information on bears.

The Brentwood Conservation Commissions Protects Ag Land

Working with <u>Southeast Land Trus</u>t Brentwood completed the conservation of the Fuller property off Pickpocket Road. The property features 28 acres of field, forest, and wetlands and abuts two easement properties, providing crucial wildlife connectivity. In addition, the fields contain rich agricultural soils, making the property a prime site for a future farm. For this reason, the easement contains an OPAV (Option to Purchase at Agricultural Value), a tool to help ensure that the next steward of the property will actively farm the land. A large portion of the project's cost was paid by the town of Brentwood through a recently passed conservation bond. **Read more**.

The New Hampshire Department of Environmental Services (NHDES) is
drafting a Comprehensive Climate Action Plan (CCAP) as the next deliverable
under the EPA Climate Pollution Reduction Grants (CPRG) program. Due in
December 2025, the CCAP will identify and model potential measures to
reduce emissions of greenhouse gases and associated air pollution. NHDES
staff will give an overview of the process plan for CCAP development,
including the schedule of opportunities for public and stakeholder
participation. There will also be significant time for participants to engage
with NHDES staff, particularly by sharing local planning efforts on municipal
level projects, programs, and policies: success stories, challenges/barriers,
funding resources, and pilot projects.

Grant Opportunities

\$750,000 AVAILABLE for AGRICULTURAL LAND PRESERVATION GRANTS

Agricultural Land Preservation grants will be available to assist municipalities and non-profit land trusts who are working to preserve active farmland for future agricultural production through easements. The Department of Agriculture, Markets, and Food's has announced that \$750,000 in grant funding will be made available through its Agricultural Land Preservation program. The goal of this round of grants is to partner with other funders to maximize the number of farms preserved throughout the state. The Agricultural Land Preservation Program's 2025 grant round is now open. Funding proposals will be due by April 11, 2025. Grant funds, which will be awarded through a competitive grant process, will assist eligible entities, including land trusts and municipalities, in preserving New Hampshire's farmland through the acquisition of agricultural land preservation easements. NEW ENGLAND GRASS ROOTS ENVIRONMENTAL FUND

Grants to fund community involvement in projects that address environmental issues including agriculture, air quality, alternative energy, aquifer protection, biotechnology, community gardens, environmental justice, energy conservation, forestry, global warming, land trusts, marine environment, public health, sprawl, sustainable communities, toxics and hazardous waste, trails, water quality, watershed management, wetlands, wildlife, and youth-organized environmental work. **SEE WEBSITE**.

FUNDS AVAILABLE TO PROTECT WILD PLACES

The Conservation Alliance (TCA) protects outdoor spaces and wild places through the collective power of its member companies. TCA members' annual contributions go directly to its grants program. Twice a year, TCA's **Member-Directed Grants** provide support for projects that seek to secure lasting and quantifiable protection of a specific wild land or waterway. As part of this process, TCA member companies nominate up to two organizations to apply for funding of up to \$50,000 and help to select grantees who are committed to creating a healthy, liveable planet for all. Organizations should connect with **member companies** in their state to secure a nomination. This program is led by an advisory committee made up of individuals from member companies, philanthropy, and
